## **GENERAL RESPONSIBILITIES OF THE REPUBLICAN PARTY**

Promote the election to office of qualified Republican persons.

Foster loyalty to the Republican Party.

Represent the precinct voters and not yourself in the Republican Party; and represent the party and its candidates and officers to the precinct voters.

Promote an informed electorate through political education.

Increase Republican Registration; help register voters, update the voter list, urge voters to turnout, pass out literature in your precinct. Reach out to every new person moving into your precinct. Welcome them and encourage them to vote Republican. During every election cycle assist in supporting efforts for absentee ballots to those who need them, and stress the importance of each and every vote. Set a personal goal as to how many votes you are going to increase turnout in your precinct.

Seek qualified Republicans to become candidates for local, county, state and federal offices.

After the Primary Election promote and support all Republican candidates in every election.

Attend meetings of your county or legislative district and stay informed of issues in your area. Stay involved in the community in which you live. In addition you will be part of the county or district volunteer force. You will be notified of meetings and political activities, including direct door-to-door contact in various precincts. It is your responsibility to participate to the extent your time permits.

Assist with fund-raising events.

Volunteer to help on various campaigns.

Reach each individual personally by knocking on doors in your precinct before each election with literature on candidates and issues.

In general to uphold the principles of freedom, equality and justice on which the Republican Party and the government of this nation is founded, as set forth in the Constitution of the United States and the state of Florida.

# **DUTIES OF PRECINCT COMMITTEE MEMBERS COLLIER COUNTY REPUBLICAN EXECUTIVE COMMITTEE (CCREC)**

## **Duties Per the Constitution and Bylaws**

- (a) Attend all meetings held the first 1st Monday of every month at 7:00 p.m., at the County Commission Chambers, 3rd Floor, Collier County Government Center, and any special meetings called by the Chairman or membership.
  - a. If unable to attend the monthly meeting, communicate the reason for your absence to the Chairman and Secretary. **Dismissal from the committee is automatic** after (3) consecutive meetings missed without an excused absence.
  - b. Notify your alternate in advance if not able to attend the meeting. Alternates can vote only in the absence of the primary committee person.
- (b) Attend an Orientation Session within six (6) months of becoming a Precinct Committeeman or Committeewoman.
  - a. Orientation Sessions are conducted monthly. **Dismissal from the committee may result in not attending an Orientation.**

## Republican Party of Florida Party Loyalty Oath

I further swear or affirm that, in a contested Republican primary election, I will not support the nomination of one Republican candidate over another in my capacity as a Republican County Executive Committee member unless the Party has voted to endorse under RPOF Rule 8. This provision does not preclude me from supporting in any manner my personal Republican candidate of choice in a contested Republican primary election, provided I do not express such support with public reference to my title or office within the Republican Party of Florida.
